NOTIFICATION OF ELECTRICITY LINE SERVICE CHARGES

Pursuant to the Commerce Commission's Electricity Distribution Information Disclosure Determination 2012, Aurora Energy Ltd hereby gives notice that the following Distribution and Transmission charges will apply for energy delivery from 1 June 2014. Current charges are also detailed as required by regulation. New prices result from the combination of changed conveyance expenses from The Power Company and increased maintenance and administration costs.
